INTRODUCTION:

The Times of India Group is India's largest and oldest media entity, with a 180+ years legacy of trust, knowledge and public service. The University has been established under the Bennett University, Greater Noida, Uttar Pradesh Act, 2016 (U.P. Act No. 24 of 2016). The same has been gazette notified by the Government of Uttar Pradesh Vide No 1042/79-V-1-16-1(Ka) 25-2016 Dated 16 Sep 2016. After notification of the Uttar Pradesh Private Universities Act, 2019, the University has been incorporated under same. It admitted its first batch of students in B.Tech., MBA and Ph.D. programs in 2016, and has since, added many programs in other areas.

includes SC/ST, General category and 2 seats for Kashmiri Migrants; 15% seats may be available for NRI/International category students, subject to maximum strength permitted under BCI rules. In case the seats remain unfilled in one category, such seats shall be transferable to other categories.

- \$ 25% seats shall be available under this category, subject to candidates meeting the minimum cut off marks, decided by admission committee of the University. The numbers of seats allocated to each category can be changed with approval of statutory authority of the University.
- 3. Merely filling an application form does not entitle a candidate for admission. The admission is purely based on performance in qualifying/eligibility examinations. The University reserves the right to cancel/revoke its offer and/or acceptance of provisional admission at any point in time.

- **4.** No refund of application fee is allowed under any circumstances whatsoever.
- 5. Candidate cannot claim the seat, merely because it is available. University Admission Committee shall decide the minimum cut offs for various programs and same shall be final.
- **6.** Candidate must fulfill all the eligibility criteria as laid down in succeeding paragraphs, if he/she wishes to be considered for admission.
- 7. Non- submission of Marks of 10+2 or equivalent examination, IDBP points and/or LSAT-India / CLAT Score, to the University, shall debar a candidate from being considered for admission.
- 8. All candidates shall be communicated guidelines, results and other details including offer letters through e-mail. Candidates are advised to check their SPAM or JUNK folder regularly and white-list the email id: admissions@bennett.edu.in. Please note that this is the only official mail ID of the University, for all communications related to admissions. Communications received from other mail IDs, may be advisory in nature, but cannot be quoted as official position of the University, specially w.r.t marks, eligibility, and admission offers.
- 9. NRI/ International Category candidates (as defined in document below) having taken qualifying exams from boards abroad, shall be considered provided they fulfill other eligibility criteria as defined in paragraphs below.
- **10.** Merit based Admission Scholarships are available, details of which are given on the University web site and shall also be provided in admission offer letters.

ELIGIBILITY CRITERIA:

- 1. Criteria of minimum Educational Qualification.
 - (a) The candidate must obtain minimum of 60% aggregate marks in **10+2 or equivalent examination** in any discipline (aggregate % shall be calculated based on 4 specified subjects as listed in **Annexure-1**).
 - (b) English shall be required Mandatory subject in the 10+2 Examination.
 - (c) Candidates who are offered provisional admission based on declared scores in the application, will be required to produce proof of having passed the qualifying examination i.e. (10+2 or equivalent e.g. IBDP, Cambridge (IGCSE) diploma/certificate or any other foreign board)/CLAT/LSAT-India Score to the University authorities, during document inspection at the time of registration (tentative 4th week of July 2020), failing which, such provisional admission will stand withdrawn. It shall be responsibility of the candidates to bring out variations in the scores/marks recorded in the admission offer letter and actual marks obtained in qualifying/eligibility examination, before accepting the admission offer. Any deviations detected even at a later stage after registration, shall render the offer of admission/Scholarship or admission itself, as invalid.
 - (d) Students are advised to download CLAT mark sheet immediately on declaration of results, as the provision for same is removed by CLAT conducting authorities, with in few days after results. Not producing a CLAT score card, due to un availability, because of default, shall not be accepted.
 - (e) If the results of 10+2 examinations are likely to be delayed beyond the date of registration (tentatively 4th week of July 2020), such candidates are advised to seek admission next year. No representations for extension of dates for verification of documents shall be entertained.

- (f) Any wrong declaration of marks /scores in the application, which provide undue advantage, if detected even after registration, shall lead to disqualification of the candidate and withdrawal of admission or scholarship, as the case may be.
- 2. Eligibility conditions for IBDP /Cambridge (IGCSE) qualified Candidates. (All candidates shall be required to obtain the 10+2 equivalence certificate from AIU on or before 03 Aug 2020). Failure to do so may lead to cancellation of admission.

(a) For IBDP Examination

- (i) Student should have secured a minimum of 26 points.
- (ii) Student should have passed minimum of three subjects at Higher Level (HL) and three at Standard Level (SL). English shall be a mandatory subject.
- (iii) Should have completed DP core, comprising theory of knowledge (TOK), creativity, activity, service (CAS) and the extended essay (EE).
- (iv) Students provided provisional admission based on predicted scores received from counsellors, shall be allowed to register only after providing regular Diploma mark sheet.

(b) For Cambridge International Examinations (IGCSE)

- (i) Percentage Uniform Marks shall be allotted equal weightage as 10+2 from CBSE.
- (ii) Candidates should have passed minimum five subjects at 'O' level including English, and minimum 2 subjects at 'A' level. This is a mandatory requirement to obtain 12th equivalence certificate from AIU.
- (iii) Further, the candidates should obtain 60% aggregate in percentage Uniform marks of four subjects.
- (iv) Should have passed English at 'A" level.

3. Eligibility conditions to be eligible for admission under NRI/International Category:

(a) NRI/PIO/OCI:

- (i) PIO (Person of Indian Origin). A person who or whose any of ancestors were Indian national and who is presently holding another country's citizenship/nationality i.e. he/she is holding foreign passport.
- (ii) OCI (Overseas Citizen of India). A person registered as "Overseas Citizen of India" (OCI) cardholder under section 7A of the Citizenship Act, 1955.
- (iii) NRI shall be a student, whose mother or father, first degree relation including the real brother and sister or grandparents both paternal and maternal are NRIs.
- (iv) This quota may also be availed by wards of NRI persons, who should be the nearest relation to include real brother and sister of father and mother i.e. real uncle and real aunt, first degree-paternal and maternal cousins. However, such persons, who have looked after such student as the guardian, need to produce an evidence to the effect, along with an affidavit signed by authorities in country where such person is residing.
- (v) NRI, in this context shall imply An Indian citizen who is ordinarily residing outside India and holds an Indian Passport.
- (vi) Students having done their 10+2 from foreign Boards and falling under categories (i) to (v) above shall be treated under NRI category admission.

(b) International Student:

All students who are foreign country pass port holders and who have passed their 10+2 exams from a foreign board shall be required to obtain the 10+2 equivalence certificate, including subject wise percentage of marks from AlU on or before 04 Aug 2020.

4. Routes to Admission:

Candidates who fulfill the eligibility as above, shall be required to have one of the following routes for admissions, which are explained subsequently, in the document:

- (a) CLAT-2020
- (b) LSAT-India 2020
- (c) 10+2 or equivalent level Examination in any stream.

5. General Instructions on conditions of Eligibility:

- (a) Candidates must produce certificate of proof of the above conditions at the time of registration (tentative 4th week of July 2020) for the program failing which, they will be disqualified, and provisional admission shall be cancelled.
- (b) Admission granted, and scholarship offered to a student may be revoked for noncompliance/not meeting the admission criteria/ being found ineligible, even if same is detected at a later date. All admissions will be subject to verification of facts from the original certificates/ documents of the candidates. The decision of the Admission Committee of the University regarding the eligibility of any applicant shall be final.

APPLICATION PROCESS:

- 1. **How to obtain and Fill the Application Form:** The students may fill the application forms on line using net banking/credit/debit card at https://applications.bennett.edu.in.
- 2. There is no separate on-line application form for the NRI/International students. However, students shall be provided an option to be considered under NRI category and which shall then lead to downloading of a sponsorship letter, which must be filled and sent to the University, to enable application being considered.
- 2. Cost of Form: Rs 1000/-, /-(can be paid online or through Demand Draft)
- **3.** Where to send. The completed Application Form, (only when hard copy purchased), must be sent to the following address:

4. Important to note before submission of Application Form.

- (a) The candidates must go through and undertake the important terms and condition available at start of on-line application form and ensure to read the admission procedure document carefully, as updated from time to time on the University's website before applying for admission.
- (b) **Application Status**: Candidates applying shall receive a unique Application No. and an e-mail acknowledging the receipt, along with further guidelines.
- (c) Candidates shall receive reminder mails, if required, and thus must view the mails from the University and comply with guidelines.

- (d) Candidates are also advised to keep a downloaded copy of Application Form. All issues regarding application form, marks or data filled there in, must be resolved by the candidate with admission section of the University, before declaration of admission offers. No appeals thereafter are acceptable.
- (e) Scan copies of 10th/12th standard mark sheets along with LSAT-India/CLAT score card as applicable, (if results have been announced) must be uploaded on the online form or while filling the marks and before submission of application.

PROCESS FOR ADMISSION:

Submission of Application/Registration of candidature. Registration of candidature implies filling online application, providing the marks/scores and uploading of mark sheets as required:

- (a) The candidate may fill the application form without waiting for the results of 10+2 examination, IBDP/ Cambridge (IGCSE) board or LSAT-India/CLAT results.
- (b) IB students, who fulfill the required eligibility criteria, may also fill the form of the University, based on predicted scores (provided by counselor only, directly to University at email ID admissions@bennett.edu.in. The students should thereafter inform the University, on above mail ID giving reference of the program and application number.
- (c) It is essential for the candidate to provide the marks of examinations as given at (a) above, immediately, after declaration of results. The marks may be filled online. Non-Compliance shall be at candidate's risk and no claim can be made for consideration for admission.
- (d) **Candidate** must fill all mandatory details and submit the final application, before being considered for admission.
- (e) **Further**, the candidate has to produce the mark sheet of all relevant exams based on which provisional offer is made at the time of document verification during registration process (tentative 4nd week of July 2020).

ADMISSION OFFERS/ALLOCATION OF SEATS:

- **1. Eligibility for Admission** Candidates shall be considered for admission process, only after they meet all of the following criteria:
 - (a) Those who apply in the prescribed application form online/offline.
 - (b) Those whose applications are found valid and complete.
 - (c) The applications are received before the due date.
 - (d) Those who fulfill the eligibility criteria.
 - (e) Where the applicants provide the required scores before the last date as per table of offers below.

2. Drawing of Selection Lists (10+2/equivalent Examination based-Indian Boards/IGCSE/SAT)

- (a) The list shall be drawn based on the cut off scores in 10+2 aggregate percentage /LSAT-India/CLAT score, as applicable.
 - (i) 10+2 or equivalent examination (% shall be calculated based on four subjects as specified at Annexure-1, duly normalized by Bennett University for state boards with respect to CBSE as per available percentile data).
 - (ii) Predicted/Actual scores or Percentile Uniform marks in Cambridge (IGCSE) / IBDP.

- (iii) LSAT-India / CLAT Score subject to meeting eligibility of 60%aggregate marks in 10+2 examination in specified subjects. CLAT/LSAT-India (percentile) Scores in any category (like SC/ST) shall not be taken into consideration.
- (b) The list for SC/ST candidates and wards of Kashmiri migrants shall be drawn subject to eligibility, and by applying the 5 percentile below the LSAT percentile cutoff or 10% below the Marks in 10+2 or equivalent examination /CLAT score, obtained by the candidate, short listed in the general category.
- (c) The wards of Defense Personnel will get a 2% (10+2/CLAT) scores / 2% percentile (LSAT) relaxation in marks criteria for the candidate, short listed in the general category.
- (d) Differently abled candidates shall get a 2% (10+2/CLAT)scores / 2% percentile (LSAT) relaxation in criteria for the candidate, short listed in the general category.
- (e) More than one list may be announced, as required as per schedule in table below.
- (f) Candidate cannot claim the seat, merely because it is available, in case he/she does not meet the minimum cut off marks decided by the University Admission Committee.

3. Drawing Lists-IBDP candidates.

- (a) IBDP candidates, who may take CLAT/LSAT-India Examinations, shall be selected as per procedure explained above.
- (b) Those candidates, who have not taken CLAT/LSAT-India examination; the offer shall be made, subject to eligibility criteria and based on IBDP points, subject to minimum of 26 Points and completing other diploma requirements.

4. NRI/ International Category.

- (a) Candidates wishing to take admission under this category must meet the definition as given above.
- (b) The candidates opting for this mode of admission are also required to provide sponsorship letter and equivalence certificate of marks from foreign board, from AIU.
- (c) List shall be drawn based on percentage obtained in 10+2 or equivalent Examination / LSAT-India/CLAT Score as above, subject to fulfilling other eligibility criteria as indicated for Indian board students.

5. Official Communication of Information about Seat Allotment and Fee payment.

- (a) The selected candidates shall be sent an email with admission offer letter. (Candidates are advised to check Please check their SPAM or JUNK folder regularly and white-list, admissions@bennett.edu.in. Please note that this is the only official mail ID of the University for all communications.
- (b) It is responsibility of the candidate to monitor the mails, as per general schedule /important dates announced, to know about their admission offers, fee payment schedule, guidelines and instructions etc.
- (c) Ignorance of schedule or not checking the details in time shall not be accepted as an excuse to attend or claim for admission at a later date.

The candidates admitted shall be required to deposit (i) tuition fees -INR 1 Lakh/ US\$ 1500 and (ii) 25000/-/US\$ 1000 towards hostel Charges if candidate wishes to opt for Triple sharing /or 50000/-/US\$ 1250, on double sharing basis, as advance installment of first semester, for booking of seat offered, and also as commitment to pay balance tuition fee for the semester, within the scheduled times given in the offer letter, failing which, the offer shall be passed on the next eligible candidate

+ The fees do not include any charges for additional certifications, modules, immersions, trainings, industrial visits etc. which shall be charged to students as and when such activities are planned.

The management reserves the right to revise the fee, hostel or other charges from time to time with prior notice.

@ Student may opt for Hostel as below (Charges shown are inclusive of Boarding, lodging and Laundry.

- (i) **Triple Occupancy.** INR 1.50 Lakhs/US\$2500 per annum.
- (ii) **Double Occupancy.** INR 1.75 Lakhs/US\$3000 per annum.
- (iii) The Choice once exercised shall generally be treated as final. However, based on requests , it may be changed, if the seats are available in either type of hostel, after student registers for the program and clearance of dues, if applicable.

Hostel accommodation shall be provided to all students, as per choice exercised. Given the rigor of the programs including class room work, it is recommended that all students avail of the hostel facilities. However, University shall allow day scholars. It should be noted that students are not permitted to bring private vehicles inside the Campus

Optional Transport charges for Day scholars per semester (payable at the beginning of the semester) is Rs 15000/-per semester for boarding from Noida (Botanical Garden) and Rs 10,000/- per semester for boarding from Greater Noida.

The Tuition fee shall be required to be transferred from the foreign or NRE account of NRI sponsor or Foreign national. The remittance instructions shall be issued along with admission offer letters. (Student admitted under this category cannot be converted to general category in subsequent years)

The University shall not entertain any request for extension of the deadline for submission of fee.

SCHOLAR SHIP

The Bennett University Admission Scholarships will be awarded only for the first year of Undergraduate program as per table below. Thereafter, the student will be eligible for Academic Scholarship, subject to meeting continuation criteria. The Number of scholarships, continuation conditions, conditions for award of Academic Scholarship and other terms and conditions are given on the web site of the University and shall be treated as final.

- (i) PIO (Person of Indian Origin). A person who or whose any of ancestors were Indian national and who is presently holding another country's citizenship/ nationality i.e. he/she is holding foreign passport.
- (ii) OCI (Overseas Citizen of India). A person registered as "Overseas Citizen of India" (OCI) cardholder under section 7A of the Citizenship Act, 1955.
- (iii) NRI shall be a student, whose mother or father, first degree relation including the real brother and sister or grandparents both paternal and maternal are NRIs.
